## PURPOSE

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

## 1. WHAT IS THIS PRODUCT?

### TYPE

An Over the Counter (OTC) derivative contract – Opzione europea call eur/put divisa (Export)

### TERM

The product has a fixed contractually agreed term and will terminate after 1 year.

### OBJECTIVES

Opzione europea call eur/put divisa (Export) products are used for managing foreign currency risks.

An Opzione europea call eur/put divisa (Export) is an agreement between two contracting parties (client/UniCredit S.p.A.) which gives the buyer of the Opzione europea call eur/put divisa (Export) the right but not the obligation to exchange an agreed amount of one currency for another currency at an agreed fixed rate on an agreed future date.

With the purchase of an Opzione europea call eur/put divisa (Export), you acquire the right but not the obligation to sell an amount of a specific currency (e.g. USD notional amount) and buy an amount of another currency (e.g. EUR notional amount) at an agreed fixed rate (strike rate) on an agreed future date (settlement date). You may exercise your right on an agreed date (expiry date).

In order to purchase this right, you will pay a non-refundable option premium.

Whether or not you exercise the Opzione europea call eur/put divisa (Export), you will not get back the premium you paid.

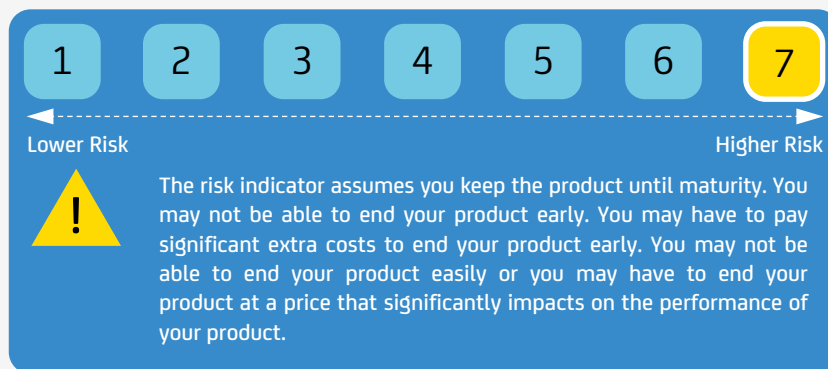
- hold this product for the contractually agreed term,

## 2. WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

### RISK INDICATOR

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class.



Be aware of currency risk. You may pay and/or receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

In some circumstances you may be required to make payments to pay for losses. The total loss you may incur may be significant.

The favourable, moderate, unfavourable and stress scenarios represent possible outcomes, which have been calculated based on simulations using the past performance of the currency pair over the past 5 years. The stress scenario shows what you might get back or pay in extreme market circumstances.

This product cannot be easily cashed in. This means it is difficult to estimate how much you would get back if you cash in before the end of the recommended holding period. You will either be unable to cash in early or you will make a large loss if you do so.

## 3. WHAT HAPPENS IF UNICREDIT S.P.A. IS UNABLE TO PAY OUT?

The investment on this product is exposed to the credit risk, meaning in the case UniCredit S.p.A., as a result of the reduction of its solvency due to financial trouble, bankruptcy, insolvency or over-indebtedness, becomes unable to fully repay the amounts that are due in relation to this product. In the case, you may lose in full or in part the payments you made or suffer unlimited losses.

Furthermore, according to the applicable law on "Bail-in", the competent resolution authorities may take certain resolution measures, such as the early termination of the derivative transactions. In this case, you are exposed to the risk of partial or complete reduction of your claim or in a conversion of your claim into equity, in a permanent way, even without a formal insolvency declaration by UniCredit S.p.A.

## 5. HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

### Recommended holding period: 1 year

The recommended holding period corresponds to the contractually agreed term. You are not entitled to unilaterally terminate the product prematurely. However, the right of early termination may be agreed for one or both contracting parties. In the event of an agreed early termination, you will either receive or pay a compensation payment, which is made up of the market value of the product and the termination costs, including a margin earned by the bank. Significant additional costs may be incurred.
